
# **SMALL BUSINESS CONCERN**

- ✓ **What is a Concern?**
  - **FAR 19.001 Definition**
- ✓ **What is a Small Business Concern?**
  - **FAR 19.001 Definition**
- ✓ **NAICS Code 332993, Ammunition (except small arms) Manufacturing**
  - **Size Standard is 1,500 Employees**
  - **Self-Certification as a Small Business and Compliance with Limitations on Subcontracting**



# LIMITATIONS ON SUBCONTRACTING

- ✓ What are Limitations on Subcontracting?
  - FAR Clause 52.219-14
  - 13 CFR 125.6 Definition
  - Manufacturer Must Perform at Least 50% of Cost of Manufacturing (minus cost of materials)
  - Cost of Manufacturing
  - Cost of Materials
  - Subcontract Costs
- ✓ Compliance as a Joint Venture


